Majalgaon.Dist.Beed (name of the school with address) for Class 1st to 8<sup>th</sup> for a period of three years w.e.f. 01/02/2025 to 31/01/2028 The above sanction is subject to fulfillment of following conditions:-The grant for recognition is not extendable and does not in any way imply any obligation to recognize or affiliate beyond Class VIII.

1. The School shall abide by the provisions of Right of Children to Free and Compulsory Education Act, 2009 (Annexure 1) and the Maharashtra Right of Children to Free and Compulsory Education Rules, 2011 (Annexure II).
2. The School shall admit in class I, to the extent of 25% of the strength of that class, children belonging to weaker section and disadvantaged group in the neighbourhood and provide to them free and compulsory elementary education till its completion. - (vi) The teachers are recruited with minimum qualification as laid under section 23(1) of the Act. Provided further that the current teachers who, at the commencement of this Act do not possess minimum qualifications shall acquire such minimum qualifications with in a period of 5years;
- (vii) The teacher performs his or her duties specified under section 24(1) of the Act and
- (viii) The teachers shall not engage himself or herself for private teaching activities.

7. The School shall follow the syllabus on the basis of curriculum laid down by appropriate authority.

8. The School shall enroll students proportionate to the facilities available in the school as prescribed in the section 19 of the Act.

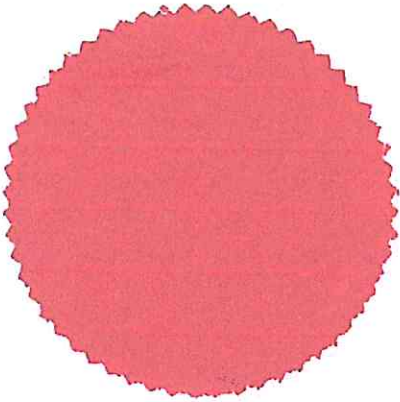
